TERMS & CONDITIONS OF SALE

In these Terms and Conditions of Sale, AUDREY LANE LLC, is referred to as "AUDREY LANE", any third-party manufacturer of flooring or other products sold hereunder is referred to as "Manufacturer" and the customer or person or entity purchasing AUDREY LANE's or Manufacturer's products (the "Goods") from AUDREY LANE is referred to as the "Buyer". For purposes of these Terms and Conditions of Sale, order confirmation and pro-forma invoice shall be interchangeable.

These Terms and Conditions of Sale, and AUDREY LANE's order confirmation (usually in the form of a pro-forma invoice) constitute the complete and exclusive agreement and understanding governing the sale of Goods by AUDREY LANE to Buyer (the "Agreement") and supersede all prior agreements, understandings or representations, whether written oral, among the parties with respect to such matters. Provided, however, that if any term, provision or condition of AUDREY LANE's order confirmation should conflict or be inconsistent with any term of these Terms and Conditions, then the terms of AUDREY LANE's order confirmation shall prevail and control such conflicting and/or over inconsistent terms.

BY ACCEPTING **AUDREY LANE**'S ORDER CONFIRMATION,

PRO FORMA INVOICE AND/OR INSTRUCTING AUDREY LANE TO SHIP GOODS (EITHER VERBALLY. BY FACSIMILE OR F-MAII COMMUNICATION), BUYER DOES MANIFEST ITS ACKNOWLEDG-MENT, **ACCEPTANCE** AND THESE **AGREEMENT** TO **TERMS** AND CONDITIONS.

AUDREY LANE reserves the right to refuse any order, in its sole discretion. No order is accepted by AUDREY LANE until: (i) AUDREY LANE provides Buyer with a written order confirmation, and (ii) Buyer duly signs the order confirmation in acknowledgement, acceptance and agreement, and returns the signed order confirmation to AUDREY LANE.

1. <u>PRICES</u>: All prices for Goods, including, but not limited to, those specified in AUDREY LANE's price list or schedule, website or written quotation, are subject

to change without notice. Such prices shall be automatically adjusted to reflect AUDREY LANE's prices for Goods as in effect at the time of the requested shipment date, and each shipment will be invoiced at such adjusted prices. Unless otherwise expressly agreed by AUDREY LANE in writing, all prices are EX WORKS (which shall have the same meaning as in the Incoterms 2000 published by the International Chamber of Commerce), exclusive of any applicable taxes, duties, sales taxes, transportation and insurance costs or charges (collectively "Charges"), which Charges are to be borne exclusively by Buyer.

2. <u>TERMS OF PAYMENT</u>: Unless otherwise expressly agreed by AUDREY LANE in writing in AUDREY LANE's order confirmation, the purchase price for all orders shall be paid in full in advance of shipment.

All payments must be made in U.S. currency. In the event Buyer fails to make any payment when due, AUDREY LANE shall have the right, in addition to all other remedies available to AUDREY LANE either at law or in equity, to either terminate this Agreement immediately, without notice, or to suspend further performance under this Agreement. Buyer shall be liable for all expenses, including reasonable attorneys' fees, relating to the collection of past due amounts. If any payment owed to AUDREY LANE is not paid when due, it shall accrue interest at the rate of the lesser of 15% per annum, or the maximum amount permitted by applicable law, from the date on which such past due amount is due until the past due amount is paid in full. Should Buyer's financial responsibility become unsatisfactory to AUDREY LANE, cash payments or security satisfactory to AUDREY LANE may be required by AUDREY LANE for future deliveries and for the Goods theretofore delivered. If such cash payment or security is not provided, in addition to AUDREY LANE's other rights and remedies, AUDREY LANE may discontinue deliveries.

3. <u>SHIPMENT AND DELIVERY</u>: Unless otherwise expressly agreed in writing by AUDREY LANE, shipments are made EX WORKS (which shall have the same meaning as in the Incoterms 2000 published by the International Chamber of

Commerce). Risk of loss or damage and responsibility shall pass from AUDREY LANE to Buyer upon delivery of the Goods to carrier. Any claims for shortages or damages suffered in transit are the responsibility of Buyer and shall be submitted by Buyer directly to the carrier. Shortages or damages must be acknowledged and signed for at the time of delivery. While AUDREY LANE will use all reasonable commercial efforts to maintain the delivery date(s) acknowledged or quoted by AUDREY LANE, all shipping dates are approximate and not guaranteed. AUDREY LANE reserves the right to make partial shipments. AUDREY LANE, at its option, shall not be bound to tender delivery of any Goods for which has not provided accurate instructions. If the shipment of the Goods is postponed or delayed by Buyer for any reason, including but not limited to, Buyer providing AUDREY LANE with inaccurate shipping instructions, then Buyer agrees to reimburse AUDREY LANE for any and all transport and/or storage costs and other additional and incidental expenses resulting therefrom.

4. LIMITED WARRANTY: AUDREY LANE warrants that all ceramic tile sold by it to Buyer under this Agreement will meet current American National Standards Institute ("ANSI") specifications for the specific ceramic tile applications specified in ANSI 137.1. Subject to the limitations set forth in Section below, AUDREY LANE and Manufacturer warrant that Goods sold by AUDREY LANE as "first choice goods" are manufactured in accordance with Manufacturer's published technical standards. This limited warranty is valid for a period of one (1) year from the date of shipment of the Goods by AUDREY LANE, or (ii) the date Buyer picks up the Goods, whichever is applicable. This limited warranty applies only to "first choice goods" sold by AUDREY LANE. ALL GOODS SOLD BY AUDREY LANE OTHER THAN "FIRST CHOICE GOODS" ARE SOLD AS IS. THIS IS THE SOLE AND **EXCLUSIVE** WARRANTY GIVEN BY **AUDREY** LANE AND THF MANUFACTURER RESPECT TO THE GOODS AND IS IN LIEU OF AND EXCLUDES ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, ARISING BY OPERATION LAW OR OTHERWISE, INCLUDING WITHOUT LIMITATION, **MERCHANTABILITY** AND FITNESS FOR A PARTICULAR PURPOSE WHETHER OR NOT THE PURPOSE OR USE

HAS BEEN DISCLOSED TO AUDREY LANE OR MANUFACTURER, AND WHETHER OR NOT AUDREY LANE'S OR MANUFACTURER'S PRODUCTS ARE SPECIFICALLY DESIGNED AND/OR MANUFACTURED BY AUDREY LANE AND/OR MANUFACTURER FOR BUYER'S (OR ANY SUBSEQUENT TRANSFEREE'S, AS DEFINED BELOW) USE OR PURPOSE.

THAN REPRESENTATIONS OR OTHER WARRANTIES MADE BY **AUDREY LANE** $\bigcirc R$ **MANUFACTURER** RESPECTIVE IN THEIR **LITERATURE** AND/OR PACKAGING, NO REPRESENTATION OR WARRANTY OF ANY KIND REGARDING THE GOODS MADE BY ANY PERSON OR ENTITY INCLUDING, BUT NOT LIMITED TO, INDEPENDENT DISTRIBUTORS AND SALES REPRESENTATIVES SHALL BE BINDING UPON AUDREY LANE OR MANUFACTURER.

IF YOU ARE A CONSUMER, AND SHOULD ANY APPLICABLE LAW PROHIBIT THE DISCLAIMER OF IMPLIED WARRANTIES SET FORTH ABOVE, THEN ANY IMPLIED WARRANTIES FOUND TO EXIST WILL BE STRICTLY LIMITED TO THE DURATION OF THE LIMITED WARRANTY SET FORTH ABOVE.

Notwithstanding the foregoing, this limited warranty does not extend to any losses or damages due to misuse, accident, abuse, neglect, normal wear and tear, negligence (other than AUDREY LANE's or Manufacturer's). unauthorized modification alteration, use beyond rate capacity, improper installation, maintenance or application. To the extent that Buyer or its agents have supplied specifications, information, representation of operating conditions or other data to AUDREY LANE or Manufacturer in the selection or design of the Goods and the preparation of AUDREY LANE's quotation, and in the event that actual operating conditions or other conditions differ from those represented by Buyer, any warranties or other provisions contained herein which are affected by such conditions shall be null and void.

Buyers must notify AUDREY LANE of any defects in the Goods in writing, via certified mail to AUDREY LANE LLC, at 4337 Dardanelle Drive, Orlando, Florida, 32808 and via fax to AUDREY LANE, Inc., at (407) 521 - 1985, within thirty (30) days of Buyer's receipt of the Goods. Upon

receiving Buyer's notice of defect, AUDREY LANE shall, at its option, repair, correct or replace the Goods EX WORKS (which shall have the same meaning as in the Incoterms 2000 published by the International Chamber of Commerce), or refund the purchase price for that portion of the Goods found by AUDREY LANE to be defective. Failure by Buyer to give such written notice within the applicable time period shall be deemed an absolute and unconditional waiver of Buyer's claim for such defects. Goods repaired or replaced during the warranty period shall be covered by the foregoing warranty for the remainder of the original warranty period or ninety (90) days from the date of shipment, whichever is Notwithstanding the provisions contained in the preceding sentences of this paragraph, Buyer shall be deemed to have accepted the Goods and absolutely and unconditionally waived its rights to claim for any defects: (i) where either the Buyer or its installer detected a defect in the Goods but nonetheless commenced installation or attempted installation of the Goods, or (ii) if the Goods are otherwise modified or altered in any way.

Buyer assumes all other responsibility for any loss, damage, or injury to persons or property arising out of, connected with, or resulting from the use of Goods, either alone or in combination with other products/components.

This Section 4 also applies in the event that any entity or person (other than Buver) buvs, acquires or uses the Goods, including, but not limited to, any entity or person who obtains the Goods from Buyer (any of them a "Subsequent Transferee"). Buyer hereby covenants and agrees to provide such Subsequent Transferee with conspicuous written notice of the provisions set forth in Sections 4 and 5 of these Terms and Conditions of Sale, by providing each such Subsequent Transferee with a copy of the notice attached hereto as Exhibit "A". Buyer, furthermore, covenants and agrees that it shall not make any representation or warranty whatsoever regarding the Goods to any third party (either on behalf of AUDREY LANE or Manufacturer or on its own account), other than the limited warranty of AUDREY LANE and Manufacturer set forth in this Section 4. **BUYER** HEREBY COVENANTS AND **AGREES** THAT. SHOULD IT FAIL TO COMPLY WITH PROVISIONS OF THIS LAST PARAGRAPH OF SECTION 4, BUYER SHALL DEFEND, INDEMNIFY,

HOLD **AUDREY** LANE AND AND/OR MANUFACTURER, ITS OFFICERS, EMPLOYEES, AND AGENTS HARMLESS FROM AND AGAINST AND ALL LIABILITY, LOSS, (INCLUDING REASONABLE ATTORNEYS' FEES), OR CLAIMS FOR INJURY OR DAMAGES (INCLUDING, BUT NOT LIMITED TO GENERAL, CONSEQUENTIAL, INCIDENTAL AND PUNITIVE DAMAGES) ARISING OUT OF OR IN CONNECTION WITH BUYER'S OR **BUYER'S EMPLOYEES**'. AGENTS', REPRESENTATIVES' AND/OR INDEPENDENT CONTRACTORS' BREACH OF THESE TERMS AND CONDITIONS OF SALE.

5. <u>LIMITATION OF REMEDY AND LIABILITY:</u> THE SOLE AND EXCLUSIVE REMEDY FOR BREACH OF ANY WARRANTY HEREUNDER SHALL BE LIMITED TO REPAIR, CORRECTION OR REPLACEMENT, OR REFUND OF THE PURCHASE PRICE IN ACCORDANCE WITH SECTION 4 ABOVE.

NEITHER AUDREY LANE NOR MANUFACTURER SHALL BE LIABLE FOR DAMAGES CAUSED BY DELAY IN PERFORMANCE AND IN NO EVENT, REGARDLESS OF THE **FORM** OF CLAIM OR **CAUSE** OF ACTION (WHETHER BASED IN CONTRACT. INFRINGEMENT, NEGLIGENCE, STRICT LIABILITY, OTHER **TORT** OR OTHERWISE), SHALL AUDREY LANE'S OR MANUFACTURER'S LIABILITY TO BUYER AND/OR ANY SUBSEQUENT **TRANSFEREES** EXCEED THE PRICE PAID BY BUYER FOR THE SPECIFIC GOODS PROVIDED BY AUDREY LANE MANUFACTURER GIVING RISE TO THE OR CLAIM OR CAUSE OF ACTION. BUYER AND ANY SUBSEQUENT TRANSFEREE AGREES THAT IN **FVFNT** SHALL AUDREY LANE'S MANUFACTURER'S LIABILITY TO BUYER AND/OR ANY SUBSEQUENT TRANSFEREES EXTEND TO INCLUDE INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES. The term "consequential" damages" shall include, but not be limited to, loss of anticipated profits, loss of business opportunity, business interruption, loss of use or revenue, cost of capital or loss or damage to property or equipment.

It is expressly understood that any technical advice furnished by AUDREY LANE or Manufacturer with respect to the use of the Goods is given without charge, and AUDREY LANE and Manufacturer

assume no obligation or liability whatsoever for the advice given, or results obtained, all such advice being given and accepted at Buyer's own risk.

- 6. EXCUSE OF PERFORMANCE: Neither AUDREY LANE nor Manufacturer shall be liable for delays in performance or for non-performance due to acts of God; acts of Buyer; war; fire; flood; weather; sabotage; strikes or labor disputes; civil disturbances riots; governmental requests, restrictions, allocations, laws, regulations, orders or actions; unavailability of or delays in transportation; default of suppliers; material fluctuations in the exchange rate between the U.S. Dollar and Euro; or unforeseen circumstances or any events or causes beyond AUDREY LANE's or Manufacturer's reasonable control. Deliveries or other performance may be suspended for an appropriate period of time or canceled by AUDREY LANE upon notice to Buyer in the event of any of the foregoing, but the balance of the Agreement shall otherwise remain unaffected as a result of the foregoing.
- If AUDREY LANE determines that its ability to supply the total demand for the Goods, or to obtain material used directly or indirectly in the manufacture of the Goods, is hindered, limited or made impracticable due to causes set forth in the preceding paragraph, AUDREY LANE may allocate its available supply of the Goods or such material (without obligation to acquire other supplies of any such Goods or material) among its purchasers on such basis as AUDREY LANE determines to be equitable without liability for any failure of performance which may result therefrom.
- 7. <u>CANCELLATION</u>: Buyer may cancel orders only upon reasonable advance written notice and upon payment to AUDREY LANE of AUDREY LANE's cancellation charges which include, among other things, all costs and expenses incurred, and to cover commitments made by AUDREY LANE or Manufacturer and a reasonable profit thereon. AUDREY LANE's determination of such cancellation charges shall be conclusive. PROVIDED, HOWEVER, THAT ANY CANCELLATION MUST BE MADE BEFORE THE GOODS HAVE BEEN SHIPPED.

- 8. <u>CHANGES</u>: Buyer may request changes or additions to the Goods consistent with AUDREY LANE's specifications and criteria. In the event such changes or additions are accepted by AUDREY LANE, AUDREY LANE may revise the price and dates of delivery accordingly. AUDREY LANE reserves the right to change designs and specifications for the Goods without prior notice to Buyer, except with respect to Goods being made-to-order for Buyer.
- 9. INDEMNIFICATION: Buyer hereby covenants and agrees to defend, indemnify and hold harmless AUDREY LANE, Manufacturer, their officers, directors, employees, agents, advisers, representatives and affiliates (collectively, the "Indemnitees") from and against, and pay or reimburse the Indemnitees for any and all claims, liabilities, obligations, losses, fines, costs, royalties, proceedings, deficiencies or damages (whether absolute, accrued, conditional or otherwise and whether or not resulting from third party claims), including out-of-pocket expenses and reasonable attorneys' and accountants' fees incurred in the investigation or defense of any of the same or in asserting any of their respective rights hereunder (collectively, "Losses"), resulting from or arising out of: (i) Buyer's breach of any provision or covenant set forth in this Agreement, and/or (ii) Buyer's making of any representation to any third party regarding the Goods other than the limited warranty set forth in Section 4 above.
- 10. <u>ASSIGNMENT</u>: Buyer shall not assign its rights or delegate its duties hereunder or any interest herein without the prior written consent of AUDREY LANE, and any such assignment, without such consent, shall be void.
- 11. <u>GENERAL PROVISIONS</u>: No change, modification, rescission, discharge, abandonment, or waiver of these Terms and Conditions of Sale shall be binding upon AUDREY LANE or Manufacturer unless made in writing and signed on its behalf by a duly authorized representative of AUDREY LANE or Manufacturer. No conditions, usage of trade, course of dealing or performance, understanding or agreement purporting to modify, vary, explain, or supplement these Terms and Conditions of Sale shall be binding unless hereafter made in writing and signed by the party to be bound, and no modification or additional terms shall be applicable to this Agreement by AUDREY LANE's receipt, acknowledgment, or acceptance of purchase

orders, shipping instruction forms, or other documentation containing terms at variance with or in addition to those set forth herein. No waiver by either party with respect to any breach or default or of any right or remedy, and no course of dealing, shall be deemed to constitute a continuing waiver of any other breach or default or of any other right or remedy, unless such waiver be expressed in writing and signed by the party to be bound. All typographical or clerical errors made by AUDREY LANE in any quotation, acknowledgment or publication are subject to correction.

- 12. <u>SEVERABILITY</u>: If any provision of this Agreement shall be held invalid or unenforceable by competent authority, such provision shall be construed so as to be limited or reduced to be enforceable to the maximum extent compatible with the law as it shall then appear. The total invalidity or unenforceability of any particular provision of this Agreement shall not affect the other provisions hereof and this Agreement shall be construed in all respects as if such invalid or unenforceable provision were omitted.
- 13. GOVERNING LAW AND JURISDICTION: Agreement shall be governed by and construed in accordance with the laws of the State of Florida without reference to its conflicts of laws principles. Buyer, AUDREY LANE and Manufacturer agree to submit all disputes arising out of or in connection with this Agreement to the exclusive jurisdiction of the State and Federal courts of the State of Florida, located in Orange County. EACH PARTY TO THIS AGREEMENT ACKNOWLEDGES AND AGREES THAT ANY CONTROVERSY WHICH MAY ARISE UNDER THIS AGREEMENT IS LIKELY TO INVOLVE COMPLICATED AND DIFFICULT ISSUES, AND, EACH SUCH PARTY HEREBY THEREFORE, IRREVOCABLY AND UNCONDITIONALLY WAIVES ANY RIGHT SUCH PARTY MAY HAVE TO A TRIAL BY JURY IN RESPECT OF ANY LITIGATION DIRECTLY OR INDIRECTLY ARISING OUT OF OR RELATING TO THIS AGREEMENT, OR BREACH, TERMINATION OR VALIDITY OF THIS AGREEMENT. OR THE **TRANSACTIONS** CONTEMPLATED BY THIS AGREEMENT. EACH SUCH PARTY CERTIFIES THAT THEY HAVE NOT REPRESENTATION RELIED UPON ANY INDUCEMENT OF THE OTHER PARTY IN AGREEING TO THIS PROVISION AND THAT THEY KNOWINGLY FREELY, AND VOLUNTARILY

WAIVE THEIR RIGHT TO A JURY TRIAL. The Convention for the International Sale of Goods shall not apply to this Agreement.

- 14. <u>U.S. EXPORT CONTROL REGULATIONS</u>: All Goods sold to Buyer are subject to the export control laws of the United States and Buyer agrees not to re-sell or divert any Goods contrary to such laws.
- 15. <u>RETURNED GOODS</u>: Except as otherwise provided in the fourth paragraph of Section 4 above with respect to warranty defects, no Goods may be returned to AUDREY LANE.
- 16. <u>NO THIRD PARTY RIGHTS</u>: These Terms and Conditions of Sale create no third party rights between AUDREY LANE, Manufacturer and any person other than Buyer, including but not limited to any Subsequent Transferee. It is understood and agreed that the parties do not intend that any third party be a beneficiary of these Terms and Conditions of Sale.
